Automated Self-Administered 24-Hour Dietary Assessment Tool

Overview of the ASA24® Respondent Website and Considerations Related to Data Security and Participant Confidentiality

Updated June 2022

Extensive evidence has demonstrated that 24-hour dietary recalls provide the highest quality, least biased dietary data. Traditional 24-hour recalls, however, are expensive and impractical for large-scale research because they rely on trained interviewers and multiple administrations to estimate usual intakes. As a result, researchers often make use of food frequency questionnaires, which are less expensive but contain substantial error.

To address this challenge, investigators at the National Cancer Institute (NCI) created the Automated Self-Administered 24-hour Dietary Assessment tool (ASA24), a freely-available, web-based tool that enables multiple automated self-administered 24-hour recalls and food records. The ASA24 system was developed under contract with Westat®, a social science research firm located in Rockville, MD. ASA24 adapted the United States Department of Agriculture's (USDA) Automated Multiple-Pass Method (AMPM) and the Food Intake Recording Software System (FIRSSt) developed by Dr. Tom Baranowski of the Baylor College of Medicine.

The ASA24 system consists of a respondent website used to collect recall and food record data and a researcher website used to manage study logistics and obtain data analyses. Since 2016, the ASA24 respondent website is compatible with mobile devices and the U.S. version is available in English and Spanish, the Canadian version is available in English and French, and the Australian version is available in English. Also, since the 2016 version, ASA24 allows for the collection of both recalls and food records. This document provides an overview of the methodology and main features of the ASA24 respondent website, as well as information on security of the data collected and protections to the confidentiality of the participants of studies that make use of the ASA24 system. Images of the main respondent site screens are also included.

ASA24 Respondent Website Methodology

Respondents asked to complete a 24-hour recall or food record are guided through ASA24 using a modified version of USDA's AMPM, with two main differences, timing and order of the questions.

Timing

- The 24-hour recall asks respondents about everything they ate and drank the previous day or in the last 24 hours. Researchers have the option to set up a study to ask about food the previous day (midnight to midnight) or in the last 24 hours from the time they log in to the respondent website (e.g., 2 p.m. today to 2 p.m. yesterday). The respondent needs to complete the recall by midnight the day of the login or 8 a.m. the next day, depending on the settings the researcher selected.
- The food record, also known as a food diary, asks respondents about the foods they are eating in real time. A researcher can set up the food record to include a single-day or multiple consecutive days. Respondents can review their information, add information, and complete missed days for up to one day after completing the record. The timing of the single-day record and consecutive day record starts when the respondent logs in to

ASA24. For consecutive day records with multiple days, the first day is the day the respondent first logs in through the last day of data collection.

Order of Questions

- The 24-hour recall is based on the AMPM method where a respondent first reports all eating occasions, and then the foods, beverages, and supplements in those eating occasions. Once the respondent has reported all of the foods, beverages, and supplements they consumed, they are asked about the details of each item. After reporting the details, the respondent proceeds to the final review, forgotten foods, and usual amount questions.
- The food record is set up differently because it is considered to be “real time” reporting where respondents can log in and out throughout the day. The respondent reports their eating occasions, the foods, beverages, and supplements in that eating occasion, and then they answer the detail questions. After reporting the details, respondents are asked if this is their last eating occasion for the day. If not, then the respondent can continue to report in a similar fashion throughout the day. After the respondent’s last eating occasion, they go through the final review, forgotten foods, and usual amount questions to complete the day.
- The 2016 and later versions of ASA24, respondents report supplements similar to how they report foods as part of an eating occasion.

24-Hour Dietary Recall Methodology

There are up to nine steps or passes used by ASA24 to facilitate respondents’ reporting of 24-hour dietary recalls.

1. [Meal-based Quick List](#)

Food Record Methodology

A food record can consist of one or more days as determined by the Researcher during study setup. The days can be consecutive or nonconsecutive. Respondents are instructed to complete a food record in real time. The methodology for food records was adapted from the ASA24 methodology for 24-hour recalls described above.

The steps for any given day of a food record process include:

1. [Meal-based Quick List](#)
2. [Detail Pass](#)
3. [Meal Gap Review](#)

After each meal reported, respondents are asked if they are finished reporting for the day. If not, on their next login, they return to step 1 to report another meal. If they are finished for the day, they go to step 4.

4. [Final Review](#)
5. [Forgotten Foods](#)
6. [Last Chance](#)
7. [Usual Intake Question](#)
8. [Sleep Module, if selected by the researcher \(only available for ASA24-2020 version\)](#)

Meal-based Quick List

During the first step of a 24-hour recall, respondents are asked to provide a list of the foods and drinks consumed at each meal occasion during the reporting period. For a 24-hour recall, the researcher can define the reporting period as either the previous 24 hours from midnight-to-midnight or for the past 24-hours starting at the time of the first login.

For food records, respondents first provide a list of foods and drinks for the meal they are reporting. After reporting all foods and drinks for that meal, they immediately proceed to the Detail Pass.

Respondents are required to search to find foods, drinks, or supplements. Search results correspond to items associated with the Food and Nutrient Database for Dietary Studies (FNDDS) and dietary supplement food codes. Search results can then be filtered by food groups, if desired. Since ASA24-2018, respondents can also add recipes during this step.

Meal Gap Review

For 24-hour recalls, once Respondents finish creating their My Foods and Drinks list at the end of the Quick List step, they are asked if they consumed anything during any 3-hour gaps between eating occasions. During a Gap Review, respondents have the opportunity to return to the Quick List to add a meal(s) and the foods, drinks, and supplements they consumed.

For a food record, the Meal Gap Review follows the Detail Pass. For the midnight-to-midnight version of a 24-hour recall and for food records, Respondents are also asked if they consumed anything between midnight and the first eating occasion, and between the last eating occasion and midnight regardless of the length of time gaps.

Detail Pass

Respondents are asked for details about the foods and drinks they recorded during the Quick List, including form (e.g., raw or cooked), preparation methods (e.g., grilled or roasted), recipe ingredients, the amount consumed, and any additions (e.g., sugar, coffee cream, salad dressing). During study setup, researchers can select an option to ask respondents about the source (e.g. grocery store, farmer's market) of all or most of the ingredients in their reported foods and drinks.

Final Review

Respondents are asked to review all of the foods, drinks, and supplements they reported for the intake day. Respondents can return to the My Foods and Drinks page to edit existing items or to add meals, foods, drinks, and supplements.

Forgotten Foods

Following the Final Review, respondents are asked if they consumed any commonly forgotten foods and drinks (e.g., snack foods, fruits, vegetables, cheese, water, coffee, tea) and supplements. Respondents must select either "Yes" or "No" for each food or drink probed. For any "Yes" response, the respondent will be returned to the Quick List to add the forgotten item(s).

Last Chance

After Forgotten Foods, respondents are asked if they reported all that they consumed. If respondents want to add more foods, drinks, or supplements, they will be returned to the Quick List to add more items; otherwise, they will move to the Usual Intake Question.

Usual Intake Question

For recalls, the final question asks: Was the amount of food that you ate yesterday more than usual, usual, or less than usual?

For records, the final question asks: Was the amount of food and drink that you had on [record day] more than usual, usual, or less than usual?

Sleep Module

This optional module allows researchers to examine the associations between sleep and dietary intake, timing of eating, and other variables in the context of the 24-hour day. When researchers turn on the sleep module during the creation of new ASA24 studies, respondents will be prompted to answer questions about sleep timing, quantity, and quality after they complete their diet assessment. The questions are available on the researcher website in the document that describes the modules.

The methodology used to create the sleep module is described in the following abstract:

Depending on whether a researcher uses a dietary recall or record, they can capture different sleep periods and thus investigate different research questions.

For researchers using the recall, the sleep module includes two questions on wake time and sleep quality for the sleep period immediately preceding the first reported meal, then primarily focuses on the sleep period after the last meal. This allows researchers to assess morning fasting or how dietary intake may influence the following night of sleep.

For researchers using food records, the sleep module focuses on the sleep period prior to the first meal. A single-day food record with the sleep module allows researchers to assess how the previous night of sleep may influence subsequent dietary intake. The use of consecutive-day food records with the sleep module allows researchers to also assess how dietary intake may influence the following night of sleep.

Respondent Nutrition Report

For 24-hour recalls or food records collected using the US and Canadian versions of ASA24 from respondents 2 years and older, researchers can select an optional module to allow respondents to receive a Respondent Nutrition Report (RNR). The RNR provides information to respondents regarding how their intake on a single reporting day compares to country-specific dietary guidance and nutrient requirements.

When this optional module is selected by researchers, after they have completed their 24-hour recall, respondents will be asked if they would like to obtain a Nutrition Report about that day. Respondents who answer affirmatively are asked their age and sex, and if female, if they are pregnant or lactating. The ASA24 system then presents respondents with an RNR. The RNR provided to respondents is also available to researchers on the Researcher website. Note that the RNR will only be generated if the respondent provides their age, sex, and pregnancy/lactation status.

ASA24 Respondent Website Features

The ASA24 respondent website guides participants through the completion of either a 24-hour recalls or food records. The ASA24 website uses an extensive branching database of questions with more than 13 million pathways that allow respondents to specify portion size and preparation, and includes reminders to add frequently forgotten foods. ASA24 gives researchers control over many options.

For both types of dietary tools, researchers can select any of the following study configurations:

- Location where respondents ate
- With whom (if anyone) respondents ate
- Television and computer use during eating occasions
- Source of respondents' food
- Dietary supplement intake
- Respondents' sleep quantity and quality in relation to dietary intake (available in ASA24-2020 version only)

ASA24 allows respondents to:

- Report type and time of eating occasion
- Search for a wide variety of foods, drinks, and supplements
- Report, save, and modify recipes for use in subsequent recalls or records (only available in 2018 and later versions)
- Search results for misspelled and related food items
- Use images to report portion size
- Add or modify food, drink, and supplement choices at multiple points during the recall or record
- Report sleep timing, duration, and quality (ASA24-2020 version only)

Data Security and Protections to Confidentiality of Participants Using the ASA24 System

Respondent confidentiality is of the utmost important within the ASA24 system. Researchers using the ASA24 system do not provide NCI, Westat, or the ASA24 system with any personally identifiable data for associated with study respondents. Rather, researchers specify a user ID for each respondent and download system-generated usernames and passwords that they provide to respondents so that they may access the application.

The ASA24 system also does not collect any identifying data directly from respondents. However, IP address information is accessed for the purpose of routing information between the server and the respondent's computer—often the IP address is that of the user's Internet Service Provider (ISP).

IP addresses are not stored or tracked by the ASA24 system. However, logs of connections are kept for audit trail purposes. This information is not mined in any way but would be available if there were a legal obligation to release it.

Respondent data are protected using industry standard security controls. All data entered into the ASA24 system at the respondent's computer are encrypted by the internet browser (e.g., Chrome, Firefox, etc) while transmitted to ASA24 servers using Secure Socket Layer (SSL) Technology. SSL allows for the authentication of the sending and receiving computers.

Only a particular study's investigator(s) and the ASA24 operations team can access response data. Access is gained through usernames and strong passwords.

ASA24 Respondent Website Screen Shots

Screen layouts will vary depending upon the screen size of the device.




